

INVESTMENT PHILOSOPHY

Family businesses form the backbone of western economies. Numerous scientific studies have shown that, due to the high degree of matching interests, owner-operated companies are more successful over the long term than manager-led companies. Family businesses are more flexible and have a stronger long-term orientation. The Kapitalfonds L.K. Family Business invests in European companies that are closely controlled or managed by their owners.

INVESTMENT STRATEGY

Based on corporate figures, the fund pursues an active, value-oriented and quantitative investment policy. The investment focus is on traditional industries and service sectors which ensures sufficient trading volume as a result of market cap and free float. The fundamental valuation is the primary investment criterion. Short-term speculative purchase decisions or technical indicators have no bearing on stock selection. A systematic hedging strategy is implemented for a minor part of fund assets.

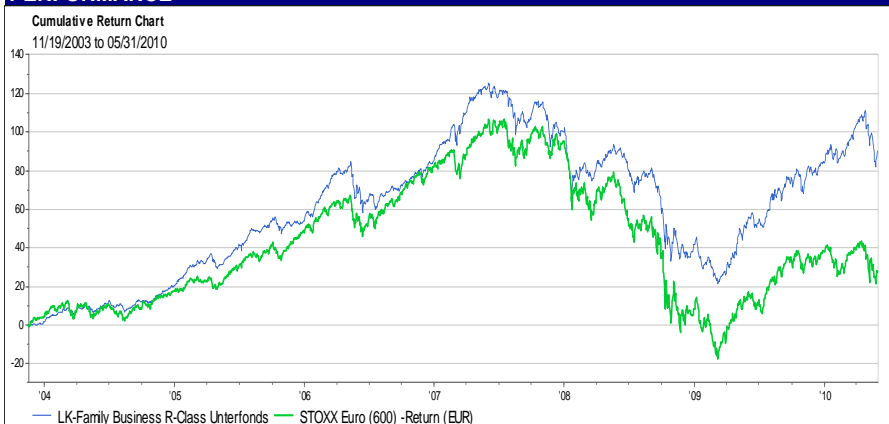

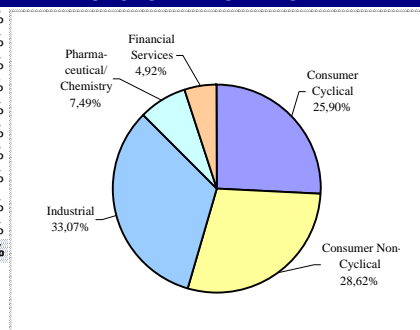
